RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as MICKELSON LANE ROAD NO. 23-141, said road traverse portions of Sections 11, 14, 23, 26 and 36 all in T.30N., R.112W. 6th P.M.;

Beginning at Station 0+00 on the northeasterly right-of-way line of State Secondary Highway No. 350, S08°-24'W, 1724.6 feet from the north one-quarter corner of said Section 36 where is found a quartzlite stone 10"x14"x8" marked $\frac{1}{4}$ North Ss on South;

Thence, N26°-30'W, 1967.8 feet to Station 19+67.8 on the north line of said E $\frac{1}{2}$ NW $\frac{1}{4}$, N87°-13W, 1131.5 feet from said north one-quarter corner;

NOW, THEREFORE, BE IT RESOLVED, That the said Board does hereby initiate the procedure for the establishment of said road and declare their intention to establish said road by following out the provision of Section 24-43.
