OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

January 2, 1974
Pinedale, Wyoming

The Board met in regular session at 9:00 o'clock A.M. on this date with Michael Marincic, Chairman and Paul C. Hagenstein Present. Also present Aune R. Clark, County Clerk and Bill Faler, Road and Bridge Foreman.

The minutes of the previous meeting was read and approved as read.

The following monthly reports were approved and ordered filed in the County Clerk's Office. Hazel P. Bloom, Clerk of Court, Aune R. Clerk, County Clerk, Robert L. McFarland, Sheriff and Paul Ziegler, Justice of Peace for the Pinedale Area. Mrs. Connie Avey, Public Health Nurse.

The following Acceptance Agreements were approved and money ordered filed in the County Treasury: Number 730, Edmund J. Giebel for Snow Explorers, \$20.00; No. 731, B. R. Dockham, Gravel Loading, \$48.00; No. 732, Betty Lou and Melvin McLoughlin, Malt Beverage Permit, \$100.00.

The following bonds were approved and ordered filed. Elma Kape, Deputy County Treasurer, \$5,000.00; William P. Slatter, Undersheriff, \$1,000.00; Lois J. Yake, Deputy County Clerk, \$2,000.00.

Petition and Affidavit for Abatement of Taxes for John A. Coppes, Farson, Wyoming, 82932. The following property has been erroneously assessed in my name, to-wit: Grazing lands were listed as meadow. In School District 9, Notice No. 2471, making a total valuation of \$5,194.00 in excess of any and all property that should be rightfully assessed against Mr. Coppes and credited with the amount of \$287.81. Reduction Tax Order No. 252, issued by a Paul Hagenstein Motion, Seconded by Michael Marincic and carried.
