



OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

February 5, 1974
Pinedale, Wyoming

The Board met in regular session on this date at 9:00 o'clock A.M. with all members present.

The minutes of the previous meeting were read and approved as read.

The following monthly reports were approved and ordered filed in the County Clerk's Office. Hazel P. Bloom, Clerk of Court; Aune R. Clark, County Clerk; Robert L. McFarland, Sheriff; Paul Ziegler, Justice of Peace.

The Following Acceptance Agreements were approved and money ordered filed in the County Treasury. No. 733, Town of Pinedale, \$300.00; State of Wyoming No. 734, \$20.00; No. 735, Hoback Realty & Ranches, \$82.00; Big Piney Cutter Races, No. 736, Beer Permit \$20.00.

The following Bonds were approved and ordered filed, Richard W. Kape, Deputy Sheriff \$1,000.00; Jean B. Risser, Clerk-Treasurer, Town of Pinedale, \$2,000.00.

Jake Pfisterer made motion we call for Bids on the Insurance for the Courthouse and all other County Property including, motor vehciles, etc Paul Hagenstein seconded and motion carried.

A discussion with Airport Board members and Vernon Delgado and John Sulenta on problems with a buried tank. Itawas suggested that Mr. Harvey Taylor call a Board meeting and decide Hbw the Board feels about this problem and then let the County Commissioners know.

Mr. & Mrs. Bob Springman and Virgina Pape of the Library Board discussed their problems, and the County paid the voucher involved out of Revenue Sharing funds.

Chuck Davis, Mayor of Big Piney and the Commissioners discussed various problems and by a Jake Pfisterer motion and a Paul Hagenstein second the Radgar will be sold to the Town of Big Piney, for the amount of \$339.66.

Mr. Thomas Muths and Bill Morganson Architects of Jackson, brought plans for the new jail complex. After discussing the problems involved, the Commissioners and Mr. Muths will meet with the Town Council whenever the Council can meet with them.
