## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

April 9, 1974  
Pinedale, Wyo.

The Board met in Special Session on this date for the Public Hearing on the Subdivision Resolution, as advertised in the local newspaper for a period of thirty days. The meeting was called to order at 7:00 o'clock P.M. with all Commission members and the County Clerk present. The Zoning Adminstrator, Bill Clark arrived at 7:30 P.M.. The following individuals were present at the Public Hearing: Billy Dockham, Mary Pfisterer, Dennis Phillippe, Bernie Gosar, Joel Bousman, Mrs. B. Richie, Warren Koch and Mr. & Mrs. James Greenwood.

The proposed Subdivision Resolution was carefully read aloud by the County Commissioners and a discussion session was held after the reading. Bill Clark, Zoning Adminstrator thought that under G. "A Central Sewage System is required when: Paragraph 6. -----then the minium lot size shall be one acre, exclusive of road set-backs as set forth in section 10 of the Zoning Resolution 10-200. A great deal of discussion on Section 4--Definitions, Paragraph T was held, with no one really agreeing on just what size acreage could be used to define agricultural usage. Since no one could agree what needed to be done, the County Commissioners stated they would ask for legal advice and then see about changing this one. Mr. Greenwood will study the proposed resolution and inform the County Commissioners of any other discrepancies he considers too dictatorial for the resolution. The Master Plan was discussed as not being quite adequate to meet the needs of Sublette County, and it was felt that this should be amended and constantly up-dated.

The County Clerk was instructed to answer Mal Holt's letter of April 5, 1974 in which a question was raised on the connection from Dubois to Tosi Creek and then to the Green River Road, in the affirmative.

Michael Marincic presented a plat for Marincic Subdivision, and after a complete explanation Jake Pfisterer moved we accept said plan but Marincic Subdivision plat is not to be filed only after Restrictions and Covenants are presented and approved by the County Commissioners. Paul Hagenstein seconded and motion carried.

No Further business the meeting adjourned at 10:15 o'clock P.M..
