

Official County Commissioners Proceedings, continued.....

May 21, 1974

Industrial Site expenses came under discussion and upon John Mackey's suggestion Paul Hagenstein moved that John Mackey ask for an attorney General's Opinion on these expenses, Jake Pfisterer seconded and motion carried.

Paul Hagenstein made a motion we accept the Big Piney Dump Ground-Costello County Road No. 23-182-1 be accepted into the County Road program, Jake seconded and the motion carried. Therefore the following Resolution was adopted.

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming deem the public interest requires that a road be established to be known as the Big Piney Dump Ground-Costello County Road No. 23-182-1 described as follows:

Beginning at Sta. 0+00. which is at Sta. 13+54.7 of the existing Big Piney Dump Ground Road, to Sta. 24+43.54 is situated in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ and NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 20, T.29N., R.111W. of the 6th P.M., and described as follows; a tract of land 100 feet in width being 50 feet on each side of a center line which begins at Sta. 0+00, located N., 65°44'36"E, 1892.74 feet from the W. $\frac{1}{4}$ Cor. of Sec. 20, thence bearing S.03°26'45"W, 1084.89 feet, thence S 18°17'37"E. 14.23 feet to a point on a circular curve to the left, having a radius of 120.00 feet and a central angle of 55°40'03", thence along the arc of said curve 116.59 feet to a point of tangency; thence S.73°57'40"E., 460.64 feet to a point on a circular curve to the right, having a radius of 130.00 feet and a central angle of 52°43'17" thence along the arc of said curve 119.62 feet to a point of tangency, thence S.21°14'23"E., 206.60 feet to a point on a circular curve to the left, having a radius of 700.00 feet and a central angle of 13°34'40", thence along the arc of said curve 165.88 feet to a point of tangency; thence S.44°49'03"E 275.09 feet to a point on the North-South centerline of the Sec., being N00° 14' tr"E 336.36 feet from the C.S. 1/16 corner.

WHEREAS, There are no patented lands.

WHEREAS, An affidavit for Right-of-way has been filed and granted by the Land Office in Cheyenne for all Federally owned Lands.

NOW, THEREFORE, BE IT RESOLVED, that the Big Piney Dump Ground-Costello County Road No. 23-182-1 be established as a public road.
