The Board met in regular session on this date with all members present.

The minutes of the previous meetings were read and approved as read.

Having been duly advertised and no protests filed a Retail Malt Beverage License was issued to Gordon E. and Donna M. Steel DBA Boulder Mercantile.

On a Paul C. Hagenstein Motion the First National Bank of Pinedale was named depository for the County Warrants for one year. Jake Pfisterer seconded and motion carried.

John S. Mackey, County Attorney, Hazel Werner, County Assessor, Donald Sparks, County Treasurer discussed the Civil Cas No. 2557 which involves taxes paid by Massey Ferguson. After much discussion Mr. Jake Pfisterer moved we settle out of court by refunding half of the amount in question. Paul Hagenstein seconded, and Jake Pfisterer then ordered the County Clerk to pay \$3,059.75 to Massey Ferguson, Incorporated, % Robert B. Ranck. This money to come out of Miscellaneous General Account. Paul Hagenstein, seconded and motion carried.

After considerable conversation on the Telephone the Bid Opening Date for the construction of the new jail was set for the 19th of August by a Jake Pfisterer Motion and a Paul Second, motion carried.

Bill Tunenga asked about having his road ploughed for the coming winter, and Mr. Jake Pfisterer felt that because of the up coming election and with only one hold over in office it would be better if, at his time, no decision was rendered. After much discussion on the new Subdivision Resolution and the requirement of an open space for each ~~space~~ planned. Mr. Tunenga felt that he should not be required to do this because there overall plan had been established before the Subdivision Resolution was adopted, and that with all of the surrounding recreation available this was not necessary. Jake Pfisterer felt that the County Commissioners could not make any exceptions.

Paul Hagenstein moved that Paul Pearson be re-appointed to the Planning and Zoning Commission for a period of five years. Jake Pfisterer seconded and motion carried.
