

Official County Commissioners' Proceedings, continued.....

August 6, 1974

Mrs. Julia Livingston asked the County Commissioners about the ownership of the scales in Daniel, and if it would be possible for her to be compensated for the use of her land on which the scales set. She felt that \$10.00 a month was not out of line for said rental, from the time they were first set up. The Commissioners stated they would talk the situation over with the Highway Department and let her know what they would do.

One April 2, 1963 the then Board of County Commissioners passed a road ordinance setting speed limits on County Roads. Paul Hagenstein moved we amend the ordinance to read:

25 Miles per hour in residence district or urban districts as defined herein.

40 miles per hour on all gravel or dirt roads.

55 miles per hour on black topped or oiled roads.

however, that for purposes hereof, buses hauling passengers for hire and vehicles under 4,500 pounds unladen weight shall not be considered commercial vehicles.

Jake Pfisterer seconded and motion carried.

William E. Clark, Zoning Adminstrator presented the following applications for building permits and for Zone Changes.

On a Jake Pfisterer motion and a Paul Hagenstein second the application of Angelo Anselmi be allowed to construct a 10 x 14' tool shed and extend roof another 10 x 14'.

Paul Hagenstein motion we allow hazel halling to install septic tank and leach hed for two bedroom usage.

On a Joe Hicks application to amend the zoning map of the Sublette County Zoning Resolution by changing 55½ acres located S½NE½ Section 12, T.33N., R. 108W (Boulder Lake) from Agricultural 1 to Rural Residential 1. Jake Pfisterer moved we advertise for a County Commissioners hearing on the above mentioned application. Paul Hagenstein seconded and motion carried. Public Hearing to be held September 3, 1974 at 2:00 o'clock P.M. in the Courtroom.
