

OFFICIAL COUNTY COMMISSONERS PROCEEDINGS

December 3, 1974

Pinedale, Wyoming

The Board met in Regular Session on this date with all members present and Commissioner Elect Bill Alexander.

The following monthly reports were approved and ordered filed: Hazel P. Bloom, Clerk of Court; Aune R. Clark, County Clerk; Robert L. McFarland, Sheriff; Mrs. Connie Avey, Public Health Nurse; Bill Meyers, Justice of Peace.

The following Acceptance Agreements were signed and money ordered filed in the County Treasury, No. 787, Northwest Pipeline Corporation, \$150.00, Gravel; No. 788, Carl Okanen, \$3.00, Subdivision Resolution, No. 789, Snow Explorer's Club, Two day Malt Beverage Permit, \$20.00.

Mr. Art Pentilla from the Mountain Fuel Company requested gravel for the road to the Mountain Fuel Camp. It will be gravelled as quickly as the Road and Bridge Department can get to it.

Mary Kay Jensen and Joe Hicks, of the Hospital Board gave a report on the D & T Center and asked the Commissioners if they should take up the Option on additional land at Marbelton. Since it had been Budgeted it was mutually agreed that the option should be honored.

The County Commissioners met with Region II Criminal Justice Board, and explained their desire to obtain the Pilot Planned Detoxification and Alcoholic Rehabilitation Center. By Unanimous agreement, reached by voice Vote, the Sublette County Detoxification Plan will be presented in Cheyenne on December 16th for approval. Judy Livingston asked about the back rent on the scales. The County Commissioners have not heard from the Revenue Department of the State Highway Department so could not give her any answer.

Bob Harrower and John S. Mackey discussed the legal description of the Land the County Commissioners would like to buy from Harold Reach that is by the present Road and Bridge building and land. Bob Harrower was instructed to survey same and Mr. Mackey was instructed to obtain all Title Insurance and Warranty Deed and whatever else was needed to complete the sale. The following Bond for School District No. 1, was approved, For \$6,000.00.
