Due to the number of people present, the meeting adjourned to the courtroom for a discussion on the zoning application, submitted by Wayne Feltner and Sulenta Construction Co., for a gravel pit on Mr. Feltner's property, containing approximately 20 acres, located in the E½ of lot 4, Section 7, T33N, R108W. In attendance were Mr. and Mrs. Wayne Feltner, George Pape, Doyle Coats, representing Sulenta Construction Co., Robert A. Harrower, Surveyor, Burton Butcher, Zoning Administrator and the following property owners from that area: Jan Taylor, Mary Skinner, Mr. & Mrs. Van Huffman, Larry Hultquist, Joe Sellyei, Russ Ecklund and Don Shriver. After the Zoning Administrator read the application Mr. Feltner stated that he felt he should be able to utilize his land in such a manner so as to provide a living for his family. The property owners objected to the gravel pit because of the traffic and road conditions, devaluation of their property and esthetic damage. Commissioner Thompson said that he did not feel qualified to render a decision without viewing the area and that the Commissioners would do so in the very near future and advise those present when they had reached a decision.

The Board returned to the County Commissioners room to meet with Thomas B. Muths, Architect, Bob Sweedler and Bill Douglas. The following bids for the emergency generator for the Sublette County Law Enforcement Facility were read aloud: Bob's Oil Co., \$17,873.00 and Douglas Electric, \$19,561.42. The Board unanimously agreed to accept the bid of Bob's accept the bid of Bob's Oil Co., in the amount of \$17,873.00 to furnish and install complete one Onan emergency generator, model 90, including 3000 gallon tank.
