OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
March 25, 1975

The Board met this date at 2:00 P.M, in the courtroom of the Sublette County Courthouse, with all members present, for the purpose of hearing two applications for an additional County Retail Liquor License based on the 1970 population census.

Also present were Mr. and Mrs. Gordon Steele, Mr and Mrs. Mark Stockton, Earl Steele, Courtney Davis, Kay Schriver, George Grassell, Paul Pearson, Bob Tanner, Emma Meeks, Carol Copeland, Don Shriver, Bruce Gooch and Mr. and Mrs. Richard Jamison.

Chairman Hagenstein read the application submitted by Gordon Edward and Donna M. Steele, dba Boulder Liquors to be located in the NE $\frac{1}{4}$ of Section 16, T32N, R108W., Boulder Store. Mr. Steele presented a statement of support signed by residents of the Boulder and Pinedale areas and stated his reasons for applying for this license. There being no further comments the Chairman then read the application submitted by Mark L. Stockton, dba Bootlegger Bar and Supper Club to be located in a log building approximately 68 ft. by 30 ft. situated in part of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 9, T35N, R111W, and Mr. Stockton read from a prepared statement his reasons for applying for the license and choice of location.

Comments from Paul Pearson, Courtney Davis, Bob Tanner, Kay Schriver and Carol Copeland favored the license being issued to Gordon Steele, at Boulder Store, if the commissioners elected to issue an additional license.
