

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

The board met in special session this date, at 2:00 P.M., with all members present.

On motion by Commissioner Alexander seconded by Commissioner Thompson, motion carried, the following resolution was adopted:

RESOLUTION

WHEREAS, LINCOLN SERVICE CORPORATION, of Frontier, Lincoln County, Wyoming and WYOMING TELEPHONE COMPANY INCORPORATED, of Pinedale, Sublette County, Wyoming, two public utilities, in order to provide electrical and telephone service to the Sublette County Industrial Site, must install their distribution systems upon and over certain lots and tracts in said Industrial Site and must therefore have consent and permission to do so, NOW THEREFORE,

BE IT RESOLVED THAT the COUNTY OF SUBLINTE, through its Board of County Commissioners, give and grant unto LINCOLN SERVICE CORPORATION, of Frontier, Lincoln County, Wyoming and WYOMING TELEPHONE COMPANY INCORPORATED, of Pinedale, Sublette County, Wyoming, its easements in the nature of a continuing covenant over and across the following described lots, tracts and real estate situate in the Sublette County Industrial Site, to-wit:

Lots numbered 5, 10, 11, 12, 13, 14, 20, 21, 23, 27, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40 and 41 of the Industrial Site as the same appears on the plat and map thereof on file and of record in the office of the Sublette County Clerk of Sublette County, Wyoming,

for the installation, construction and operation of electrical transmission and distribution lines and telephone transmission and distribution lines to all property, tracts and lots within the said Sublette County Industrial Site.

Commissioner Thompson made a motion to establish the Binning Road #23-185 as a County Road since easements have been secured from all land owners along this road and the Commissioners deem it a public interest that this county road be established. Motion seconded by Commissioner Alexander and carried.

Joe Hicks presented a road petition, to the Commissioners, duly signed by ten or more electors of the County residing within fifteen miles of the road to be established. This petition covers less than 300 yards of an existing roadway which connects the Green River Lake Road #23-156 and property in Section 13, T34N, R11W, which is being purchased by Redstone Corporation. The Board accepted the petition and appointed Billy Dockham as road viewer.

There being no further business the meeting adjourned at 4:45 P.M.

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming

May 22, 1975

The Board of County Commissioners met in a special session, this date, at 1:30 P.M. with all members and the County Clerk present.

The afternoon was spent reviewing preliminary county budgets submitted for the '75-'76 fiscal year.

There being no further business at this time the meeting adjourned at 6:30 P.M. and reconvened at 8:20 P.M. in the courtroom of the County Courthouse. Present were Paul C. Hagenstein, Robert Thompson and C. F. Alexander, County Commissioners; Marjorie Mariner, Bobbie Robertson and Sylvia Schaffer of the Tri-County Mental Health Board; Pat Nystrom, Ellen Dew, Barbara Richie, Barbara Pfaff, Pat Pearson and Rev. William Gianola of the Sublette County Health Board, Sandra Hart and Rev. Stephen Holmes.

There was a discussion as to the duties and responsibilities of the Mental Health Boards, and the members advised the Commissioners that they felt they had no say in policy making or administrative matters since the board of directors had filed "Articles of Incorporation", containing an executive clause, with the Secretary of State.

The Board of Commissioners accepted the resignation of Rev. Gianola and appointed Rev. Holmes to fulfill his two year term, on the Sublette County Mental Health Board, which will expire June 21, 1976.
