

## OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
July 1, 1975

The Sublette County Board of Commissioners met in regular session this date with all members present.

The minutes of the past meetings were approved as read.

Bonds for Virginia A. Pape as Treasurer of the Sublette County Library Board (\$4,000.00) and William W. Bloom as Deputy Sheriff (\$1,000.00) were approved and ordered filed.

The monthly reports of Nylla Kunard, County Treasurer; Jam W. Taylor, Clerk of Court; Patrick C. Mattimoe, Justice of the Peace; and Lois J. Yake, County Clerk were approved and ordered filed.

Frank Ball, Jr. met with the Board to protest the museum budget turned in to the budget officer which requested no funds for the 75-76 fiscal year. It was suggested that the museum Board might hold another meeting and present a revised budget for the Commissioners consideration.

Haskell Walker and Harvey Stone requested an application to subdivide 311 acres of land owned by Mr. Stone and located in the S<sub>1</sub>SE<sub>1</sub>, NW<sub>1</sub>SE<sub>1</sub>, E<sub>1</sub>SW<sub>1</sub>, of Section 22 and N<sub>1</sub>NE<sub>1</sub>, NE<sub>1</sub>NW<sub>1</sub>, of Section 27, T35N, R111W. On motion by commissioner Thompson, seconded by Commissioner Alexander, motion carried, this subdivision permit was granted.

Billy Dockham submitted his report as Road Viewer for a county road, requested by Redstone Corporation, located in Section 13, T37N, R110W and covering a distance of three to four hundred feet. He reported that this appeared to be in use for many years and could not see that it would damage or interfere with the present use of the property.

Gordon Tanner, from the State Examiner's office and John Mackey, County Attorney, discussed budgets and county expenditures with the Commissioners. The Board requested Mr. Mackey to inform the public, through the Pinedale Roundup, that they would publish a statement of receipts and disbursements concerning the new jail facility in the near future.

Joe Hicks informed the Board that the new D & T Center in Marbleton was nearly completed and it was hoped they would have a Dr. to begin actual practice by July 21st.

Dr. Howard Smith met with the Board to discuss a nursing home for Sublette County. He feels that it will be possible to raise enough funds, through donations to begin construction of such a facility.

Mr. and Mrs. Lawrence Bain met with the Commissioners to request better maintenance of the Merna-North Beaver Road. He would like it improved so it would be an all-weather road.

At 2:00 P.M. Chairman Hagenstein opened the hearing for transfer of funds. There being no protests on motion by Commissioner Alexander seconded by Commissioner Thompson, motion carried, the following fund transfers were approved: \$350.00 from B-17 Election Budget to B-4 County Assessors Budget, \$1000.00 from B-6, County Attorneys budget to B-9, County Coroners Budget, \$25,000.00 from B-14 Road and Bridge Budget to B-20 Miscellaneous General Budget, \$30,000.00 from Cash Reserve and \$100,660.00 of unanticipated revenue received of State of Wyoming to B-22, Capitol Outlay.

There being no protests a Malt Beverage Permit was issued to W.B. Sargent dba Rim Station Store.

The following zoning applications were presented by Burton Butcher, Zoning Administrator and approved by the Board of Commissioners.
