## RESOLUTION TO PROVIDE INCOME NECESSARY TO FINANCE BUDGET

WHEREAS, on the 28th day of July, 1975, this Board adopted a County Budget for the 1975-1976 fiscal year ending June 30, 1976 calling for the following appropriations:

And WHEREAS, after deducting all other cash and estimated revenue, it is necessary that the following amounts be raised by general taxation, and in order to raise such sums of money, it is necessary that levies be made for the 1975-1976 fiscal year ending June 30, 1976 as shown opposite each fund:

## OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
August 5, 1975

The Board of County Commissioners met in regular session this date with all members present.

The minutes of the previous meetings were approved as read.

The monthly reports of Nylla Kunard, County Treasurer; Jan W. Taylor, Clerk of Court; Patrick C. Mattimoe, Justice of the Peace and Lois J. Yake, County Clerk were approved and ordered filed.

The following Acceptance Agreements were approved and the money turned in to the County Treasurer:

- #832-Sublette County Sporting Association, \$20.00, 2 day Malt Beverage Permit
- #833-Sublette County Sporting Association, \$10.00, 1 day Malt Beverage Permit
- #834-State of Wyoming, \$5,452.42, Federal Grant (Detoxification)
- #835-Sublette County Sporting Association, \$10.00, 1 day Malt Beverage Permit
- #836-Green River Bar, \$500.00, Retail Liquor License

Vernon Delgado and Patrick Mattimoe, representing Delgado Oil Company, discussed tire adjustments and size and number of tires in stock, to fill the requirements of the successful tire bid which they received in June, with Bill Falter, Road and Bridge foreman and the Commissioners.

Jim Zuko, Manager of Commercial Tire Company of Rock Springs, informed the Board and Road and Bridge foreman that they were able to supply tires, at government prices, which were not available locally and could also supply recapping and sectioning service for approximately one-half the cost of new tires.

John Mackey, County Attorney, brought in the statement which he had prepared for publication regarding the Sublette County Law Enforcement and Emergency Operations Center. The Commissioners requested that he have it published in this weeks issue of the Pinedale Roundup.

Bud Slatter, Undersheriff, met with the Board regarding the janitorial service over the past few weeks and told them that he was willing to take the responsibility as custodian to see that it was done properly or find someone who could do so.
