OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
November 4, 1975

The Board of County Commissioners met this date with all members present.

The minutes of the October meeting were approved as read.

The monthly reports of the County Officials were approved and ordered filed in the County Clerk's office.

The following Acceptance Agreements were approved and money turned into the County Treasurer: #864-\$1,380.25, Wyoming Leasing Co., lots 40 & 41 of Industrial Site; #865-State of Wyoming, \$50,359.00, Federal Grant (jail); #866-State of Wyoming, \$799.20, P.S.E. Program, Deputy Sheriff salary; #867-U.S. Forest Service, \$1,137.80, Sheriff-Co-op Agreement; #868-Badger Uniforms, \$113.34, overpayment refund; #869-State of Wyoming, \$1,077.71, Federal Grant (Detox); #870-State of Wyoming, \$9,695.00, Federal Grant (Detox).

John Walters and Spence Garrett, of the Wyoming State Highway Dept., met with the Commissioners to review their selections for designation of proposed Rural Collector System of Roads in Sublette County. After requesting minor changes the Board concurred with their recommendation.

Bob Sweedler, of Bob's Oil Company, informed the Commissioners that the emergency generator for the new Law Enforcement Center was in place but not yet in operation. As Mayor of Pinedale he asked that the optional 1% additional State Sales Tax, for Sublette County, be placed on the ballot at the next election. When asked if the County could dispose of any seepage, which may occur in the new jail facility, through city sewer lines he answered in the negative stating that it might be possible later on.

The decision regarding an application for establishment of a county road, which was requested by Redstone Corp. over part of the SE 1/4 of Section 13, T37N, R110W, was postponed pending the settlement of a court dispute between Mr. & Mrs. James Rogers and Redstone Corporation.
