This meeting will be held November 24th at 2:00 P.M. in the county courthouse.

The Commissioners inspected the new Law Enforcement and Emergency Operations Center and postponed final payment to Bancroft Construction Inc., as advertised for this date, until November 24th at 10:00 A.M.

There being no further business the meeting was adjourned at 4:00 P.M.

The Board of County Commissioners met in special session this date at 10:00 A.M. Present were Paul C. Hagenstein, Robert Thompson, and Bill Alexander, Commissioners; Thomas B. Muths, architect and John Bancroft of Bancroft Construction Co, Inc.

After inspecting the Sublette County Law Enforcement and Emergency Operations Center the Board of Commissioners accepted as complete all work by Bancroft Construction, Inc. On Motion by Bob Thompson, second by Bill Alexander, motion carried, final settlement was made on the contract with Bancroft Construction, Inc. in the amount of \$27,920.04.

The Board met with school district officials and the road and bridge foreman to discuss the winter maintenance policy of county roads for the 1975-1976 winter season. The following resolution was duly adopted upon the motion of Bob Thompson. Motion seconded by Bill Alexander and carried.

RESOLUTION

RESOLVED THAT public and private roads within Sublette County shall be maintained throughout the winter of 1975-76 in accordance with the following priorities:

- First priority - emergencies
- Second priority - School children roads (this excludes private driveways)
- Third priority - remaining county roads

RESOLVED FURTHER THAT no private roads will be maintained without a liability release signed by the owner.

Some county roads may be closed during the winter months due to weather conditions and/or prohibitive maintenance cost. Families with school children using these closed roads should contact their school officials for isolation or tuition contracts.
