

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
January 20, 1976

A public hearing was held this date at 7:30 P.M. in the courtroom of the Sublette County Courthouse on a re-zoning application submitted by Elvin L. Booth.

Present were County Commissioners Paul Hagenstein, Robert Thompson, and Bill Alexander; James Noble and Zoning Administrator, Burton Butcher.


Mr. Booth's application requested that 290 acres of land, located approximately 2 miles north of Cora, and described as the SW $\frac{1}{4}$ of Section 28 and the N $\frac{1}{2}$ NW $\frac{1}{4}$, E $\frac{1}{2}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 33, T35N, R110W, be rezoned from Agricultural (A-1) to Recreational Residential (RR-1).

Following a discussion on impact to agriculture, water & power availability, the effect on movement of cattle, increased fire hazard and additional expense imposed on the ditch company to provide irrigation water, Commissioner Alexander made a motion that the request be denied and the application be returned to the Planning and Zoning Commission for further study.


Mr. Booth then requested that he be allowed to withdraw his application. This request was approved by the Board and Mr. Alexander withdrew his motion.

Chairman Hagenstein declared the hearing closed and the meeting adjourned.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
January 28, 1976

The Board of County Commissioners met in special session, this date at 3:00 P.M. with all members present.

Subdivision plats for the "Hoback Ranches" were submitted to the Board, for their approval, by Doyle Child, owner of Hoback Ranches, his son-in-law, Gary Jenkins and Cloey Wall, surveyor.

After the Commissioners and the County Attorney, John Mackey had examined the plats and determined that they were in order Commissioner Thompson made a motion that the subdivision plats be approved and accepted by the Board. The motion was seconded by Commissioner Alexander, Dr. Reinow and Bill Meyer.

The meeting then adjourned to the courtroom where the Board met with the following persons who had questions regarding the Sublette County Treatment Center: Jean Rahm, Irene Steele, Hazel Bloom, Larry Lozier, Connie Avey, Otto Jensen, John Welborn, Bud Sommers, Bud & Dottie Alexander, Dr. Reinow and Bill Meyer.


The Board was asked about funding and operation of this project and the number of patients treated and the results. Mr. Hagenstein said that he thought there had been around 126 patients treated to date but since he had not been prepared for this meeting he did not have the figures with him to verify this number.

Connie Avey said it was her feeling that a public meeting should be held and advertised in advance so that all interested persons would have a chance to voice their opinions in regards to this project. The Commissioners agreed and will set a date for such a meeting.


Mr. Thompson explained that at the last regular meeting he found himself in the middle since Mr. Hagenstein approved the project and Mr. Alexander was against it, therefore he wished more time to make his decision. He said that he had heard very little opposition to the project before the minutes were printed in the paper - after which he received a number of calls from people in the Pinedale area. By that time he had decided that he might be willing to budget a maximum of \$3,000.00 of county funds for the Treatment Center for three reasons: (1) because the project has not been in operation long enough to determine if it is working effectively or not; (2) \$3,000.00 is actually less money than it would cost the county to handle this problem on its own and (3) this amount is approximately 1/3 of the required matching funds and like amounts could probably be raised in other counties such as Sweetwater and Lincoln since they are also using the facility.

After some further discussion regarding cost and alternatives the meeting adjourned at 5:15 P.M. The Board requested their clerk to advertise a public meeting to be held at 7:30 P.M., February 12, 1976.
