A-1 was denied, as recommended by the Zoning Commission, for the following reasons: 1. That a precedent would be set in this area for tract of less than 10 acres. 2. The petitioner owns 28 acres in this area and could well participate in the subdivision procedures.

Decision regarding Ed Giebel's application for a subdivision permit was delayed until he has complied with all provisions of the State Land Use Planning Act.
