

Pinedale, Wyoming
July 5, 1977

The Board of County Commissioners met in regular session there being present Robert Thompson, Chairman, C.F. Alexander and Lois E. Cobb, members and Lois J. Yake, Clerk.

The minutes of the June 7th and 21st meetings were approved as read.

Monthly reports of Nylla Kunard, County Treasurer, Jan W. Taylor, Clerk of Court, Patrick C. Mattimoe, Justice of the Peace and Lois J. Yake, County Clerk were approved and ordered filed.

The following Acceptance Agreements were approved and monies turned into the Treasurer:

- #1035-Sublette County Sporting Association, \$10.00-malt beverage permit
- #1036-Lakeside Lodge, \$100.00 renewal Malt Beverage License
- #1037-Battle Mountain Lodge, \$500.00 renewal Liquor License
- #1038-State of Wyoming, \$4,700.00 Detox Grant
- #1039-Sublette County Treatment Center, \$1,356.00 Payment for treatment
- #1040-Zoning Administrator, \$10.00 copies
- #1041-Sublette County Sporting Association, \$20.00 malt beverage permit
- #1042-Sublette County /Roping Club, \$30.00 malt beverage permit
- #1043-State of Wyoming, \$20.00 rent space to issue drivers licenses
- #1044-Elkhorn Stores, \$500.00 renewal liquor license
- #1045-Rim Station, \$100.00 renewal malt beverage license

The Board reviewed the map of Favazzo Subdivision County Road No. 23-199 consisting of the road into the subdivision and Moose Street, Antelope Street, Elk Drive and Big Horn Drive. It was agreed by the Board that this would be approved as a County Road when the subdivided has constructed Antelope Street to conform to minimum county road standards.

Bill Alexander moved to adopt a resolution whereby the County will maintain only duly established county roads with the exception of snow removal in the case of emergencies. Lois Cobb seconded the motion with the amendment that this policy be followed until such time as the Board receives a ruling from the Attorney General regarding the legality of maintaining other than duly established county roads. Voting Aye: Alexander and Cobb. Voting Nay: Thompson, Motion carried.

Crowell Bean, Earle Crandall, Corky Kelly, and Pat Mattimoe came in to request that Orcutt Drive in the Orcutt Hill Subdivision be adopted as a county road after it has been brought up to minimum county road standards.

Don & Pat Wade of the Elkhorns Stores, along with Mkie Flanery, Eloise Snow, Bob McNeal and Lane Bybee were present for the hearing, July advertised for 2:00 p.m. this date, for the renewal of a liquor license for the Elkhorn Stores. All those present were in favor of renewal of the license and there were no protests against the renewal. On motion by Lois Cobb seconded by Bill Alexander, The Board unanimously approved the issuance of a renewal liquor license for the Elkhorn Stores.

The application of William Sargent, dba Rim Station Store, for renewal of Malt Beverage License was read by Chairman Thompson. Having been duly advertised and no protests filed, the renewal was approved by the Board on motion by Bill Alexander, seconded by Lois Cobb and carried.

The following resolution was adopted on motion by Lois Cobb, seconded by Bill Alexander and carried unanimously:

RESOLUTION

WHEREAS, due to the requirements that were not reasonably foreseeable at the time the budget was adopted, it is now necessary to transfer the following amounts within the county budget:

\$4,400.00 from B-17, Election Budget and \$2,000.00 from B-8, County Surveyor to B-5, County Sheriff's budget;


\$11,569.08 from the County General Fund to B-20, Detoxification and Rehabilitation Budget (Unanticipated revenue received from a \$9,444.00 increase in Federal Grant 74A-24-074 and \$2,125.08 received from patients for treatment and from donations.)

WHEREAS, public notice has been published and a copy of said notice mailed to the State Examiner, in accordance with Section 9-535, Wyoming Statutes 1957, and no protests filed,


NOW, THEREFORE, BE IT RESOLVED, that the sum of \$17,969.08 be transferred from County General Fund, County Elections, and County Surveyor to County Sheriff and Detoxification budgets.
