OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
January 17, 1978

The Board of County Commissioners met in special session at 7:30 P.M. with Robert Thompson and Lois E. Cobb, Commissioners, Janet Montgomery, Zoning Administrator, Doris Burzlander and Joe Hicks present.

On motion by Lois Cobb, seconded by Bob Thompson, and carried, the following zoning amendments were approved as recommended by the Planning and Zoning Commission:

1. Redstone New Fork River Subdivision - 176.5 acres in part of Sections 4,5,6 and 9, T33N, R109W from A-1 (Agricultural) to R-R (Rural Residential).
2. Donald D. Shriver's proposed Halfmoon Mountain Subdivision, Fourth Filing - 160 acres in part of W₁W₂, Section 7, and N₁N₂W₁, Section 18, T33N, R108W, from A-1(Agricultural) to R-R(Rural Residential).
