Mickelson Lane-?County Road #23-141, 20 M.P.H.-for that portion of road which passes between the Guio ranch buildings.


Motion was seconded by Bob Thompson and carried.



OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
February 7, 1978

The Board of County Commissioners met in regular session this date at 9:00 A.M. Present:Robert Thompson, Chairman, C.F.Alexander and Lois E. Cobb, Members and Lois J. Yake, Clerk.

Bonds of Gay L. Harrower and Ken M. McLaughlin as dispatchers for the Sheriff's office were approved in the amount of \$1000.00 each and ordered filed.

Pursuant to Chapter 165 of the 1967 Session Laws, the four special Sunday dates when all Malt Beverag and Liquor Licensees may remain open past 8:00 P.M. were approved as follows:

June 25th-Bondurant Barbeque	July 10th-Rendezvous
July 3rd-Big Piney Rodeo	Sept. 4th-Labor Day

After reveiwing the current status of the Road and Bridge budget, with Dick Evans, foreman, the Commissioners didected Mr. Evans to schedule future snow plowing operations during regular working hours, whenever possible, and in accordance with the road policy adopted at the December 6, 1977 meeting. This policy gives first priority to emergencies (those involving illness or accident to individuals), second priority to school children routes and third being other roads as time, finances and equipment permit.

Mr. and Mrs. Chuck McCarty, owners of Sublette Communications, were present to discuss the county radio communications system. Mr. McCarty has been providing maintenance for this system for a number of years under a contract with Motorola C & E. He has been unable to gain any information through Motorola concerning new or additional equipment which may be added to this system under a contract awarded to Motorola last month, and has not been contacted regarding reates to be incorporated into a new maintenance contract for this equipment. Therefore he was cancelling the maintenance contract with Motorola, effective at the end of thirty days. He said that he would continue maintenance after that date on a time and materials basis to the county in the event that a new contract had not been negotiated prior to that time.

On motion duly made by Bill Alexander, seconded by Lois Cobb and carried, the following resolution was adopted:

RESOLUTION

WHEREAS, the Board of County Commissioners of Sublette County wish to utilize the provisions of Sections 24-38, 24-68, and 24-69, Wyoming Statutes 1957, by cooperating with the Wyoming State Highway Commission in the construction or the improvement of a county road, the extent and location of work which is as follows:

Survey, design, plan preparation, rights-of-way and construction on the Cora Road beginning at the north end of Project S-1802(5) and extending north approximately 13.5 miles to the Bridger National Forest Boundary. Right-of-way on the north 6/7 miles only.

NOW, THEREFORE, be it resolved:

THAT the Board enter into a written agreement with Wyoming State Highway Commission covering said construction or improvement in accordance with the agreement attached hereto which is hereby approved and ordered filed in the office of the County Clerk of this county; that a majority of the Board and County Clerk of the county be, and they are hereby authorized and directed to execute the agreement on behalf of the Board.
