

As requested by the Town of Marblerton it was agreed, on motion by Bill Alexander, that county owned lots and the vacant building situated on these lots in Marblerton be turned over to the Town of Marblerton for use as storage and to provide space for a future office building. The motion was seconded by Lois Cobb and carried.

Having been duly advertised and no protests filed, the following resolution was adopted on motion by Lois Cobb, seconded by Bill Alexander and carried.

RESOLUTION

WHEREAS, Sublette County is the recipient of a Federal EDA Grant in the amount of \$55,000.00 obtained to aid in financing the Pinedale Medical Center;

AND, WHEREAS, these funds were not anticipated at the time the current budget was adopted and not included in same;

NOW, THEREFORE, BE IT RESOLVED, that \$55,000.00 be transferred from the General County Fund to B-20, Other General Accounts-Capital Outlay to be expended toward the construction of the Pinedale Medical Center.

Maurice Campbell, Dave Dillingham, Pat Nystrom, Bruce Anderson, Lois Koch, Judy Coryell, Barbara Burroughs and Barbara Richie attended the meeting as representatives of Western Wyoming Mental Health Association, the Four county Mental Health Board and the local Mental Health Board. Mr. Campbell presented the mental health budget for the upcoming fiscal year and requested \$8,000.00 from Sublette County which amounts to approximately \$2.00 per capita based on county population. This request will be considered by the Board at their regular budget meeting.

A request for zone variance, submitted by Nick Stadler to construct a house and utilize the basement area as a worm farm, on his property in the Tyler Subdivision was withdrawn by Mr. Stadler following opposition voiced by Dorothy Young and Frank Hankins, also property owners in this subdivision. He will delay construction of the new house until he is able to locate and purchase property zoned commercial or light industrial. In the meantime he will confine his worm farm to a small area in the basement of his present home. Since the area to be used in this manner is less than 20% of the total floor space it is a permitted use.
