

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
June 12, 1978

The Board met in special session this date with all members and Janet Montgomery, acting clerk, present.

Hank Snow was in regarding why his plat was not approved. Thompson stated commissioners were waiting for Attorney General's opinion. Makkey stated agricultural lands and parcels of 35 acres or larger exempt under state law. Alexander moved to accept plat. Cobb seconded the motion. Motion carried.

Bob Robertson, Spike Jorgensen, Goerge Barp, and Austin Richardson in regarding school bus routes. Barp stated that Sbhoool District No. 9 adopted the policy of having bus routes go to the homes of those who make a living on the land. Jorgensen stated that in School District No. 1 the policy is for the busses to travel county roads. Jorgensen asked that the county establish what its cost ratio is for snow removal. Cobb moved that the following policy be adopted regarding snow removal:
The county will only plow established and presumed county roads and school bus routes established by the local school districts. Certain portions of these roads may not be kept open if the cost of snow removal becomes too great.

Alexander seconded the motion. Motion carried. This policy is adopted as being in conformance with state law and opinions received of the County Attorney and Attorney General and filed in the County Clerk's office. Copies available upon request.

Cobb stated that with the pay increases the elected officials should work a 40 hour week as set by state law. Thompson and Alexander agreed, Hours will be discussed with the elected officials later.




John Jensen in to ask that $\frac{1}{2}$ mile of old county road #5 remain a county road. This will be considered.

The Board met in special session this date at 2:00 PM with all members and their clerk present.

The 1978-79 fiscal budget was examined and the following schedule of estimated tax requirements tentatively approved:

The estimated total General Fund requirement was tantatively approved for \$1,357,023.50 with total estimated requirements of all independent political subdivision based on the budgets submitted to the county budget officer being approved for \$321,474.17.
