Refior for enforcement, he is further authorized to initiate, on behalf of the county, legal actions for the enforcement of the county zoning and subdivision and to pursue the same to completion. The county reserves the right to rescind and revoke by resolution the above stated authority, at any time, but said authority herein granted shall be deemed to be continuous, and shall exist until so rescinded and revoked.

The November meeting of the Board of County Commissioners has been scheduled for November 14th due to the General Election to be held on the regular meeting date of November 7th.

Having been duly advertised and no protests filed the Board authorized a fund transfer of \$4900.00 from the Sanitarian portion of the Health Officer's Budget (B-18) to the Zoning Budget(B-19).

Upon motion by Cobb and second by Alexander the following resolution was unanimously adopted:

RESOLUTION

WHEREAS, the Board of County Commissioners of Sublette County deem the public interest requires that a road be established to be known as part of Ehman Lane County Road No. 23-144;

WHEREAS, the foregoing roadway traverses part of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 24, T34N, R110W, which is public land of the United States of America;

WHEREAS, the Federal Land Policy and Management Act of 21 October, 1976

requires the obtaining of a right-of-way across these lands from the Bureau of Land Management;

NOW THEREFORE BE IT RESOLVED, that the Board of County Commissioners be authorized to apply for a right-of-way across the aforesaid lands in the name of the County of Sublette and that the Chairman of the Board of County Commissioners, Robert V. Thompson, or his successor, be authorized to sign in the name of the board and the County.
