OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
October 2, 1979

The Board of County Commissioners met in regular session this date at 9:00 a.m. with Chairman C. F. Alexander, Members Lois E. Cobb and W. R. Tanner and County Clerk Lois J. Yake present.

Minutes of September meetings were approved as published.

Official Bond of Marilyn M. Jensen, as clerk of the Sublette County Memorial Hospital Board, was approved for \$2,000.00 and filed in the County Clerk's Office.

A Public Hearing was held, as advertised, on the following zoning amendment requests:

- 1. Kyle B. Walker to reclassify 10 acres, being part of the NE¼NE¼ of Section 11, T33N, R109W, from A-1 to R-R use.
- 2. Nancy Palubiak to reclassify 10 acres, being the SW¼ of Lot 1, Section 1, T33N, R109W, from A-1 to R-R use.

On motion by Lois Cobb both requests were approved, as recommended by the Planning and Zoning Commission. Motion seconded by Bob Tanner and carried.

Marilyn Jensen, Hospital Board clerk, told the Commissioners that the new ambulance has been delivered and sufficient tax money has not been collected this early in the fiscal budget year to meet the payment. They need another \$18,000.00 to pay for the ambulance plus operating expense for next month. The Commissioners agreed to transfer the necessary amount from the County General Fund to the Hospital budget, which will be reimbursed to the General Fund as taxes are collected and disbursed by the County Treasurer.
