

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
May 6, 1980

The Sublette County Board of Commissioners met in regular session this date at 9:00 a.m. with Chairman C.F. Alexander, Members Lois E. Cobb and W.R. Tanner and Clerk Lois J. Yake present. Commissioner Tanner was absent during the afternoon session.

The minutes of the April meeting were approved as published.

Official Bonds approved: Shirley Tanner as Clerk-Treasurer of the Town of Big Piney, \$1,000.00; W.F. Meyer as County Coroner, \$1,000.00; Wayne Feltner as Treasurer of the County Weed and Pest District, \$3,000.00 and Mildred Miller as Treasurer of the Big Piney Cemetery District, \$1,000.00.

Kenneth Shriver was appointed to replace Kip Alexander, who resigned, as the Cora area Board Member of the County Weed and Pest District. This term expires January 7, 1983.

Rod Bennett was appointed to the Big Piney Airport Board to fulfill the term of Wayne Poindexter which expires June 3, 1982. Mr. Poindexter will be moving from the area.

The three Sublette County tuition-free scholarships, for the 1980-81 academic year were awarded to Jannette Linn, Big Piney and Lisa Thomas and David Warren of Pinedale. The one renewal scholarship went to Roger McNinch, Big Piney. All will be attending the University of Wyoming.

The New Fork-Willow Creek Road came under discussion with County Attorney, Robert Sievers and Deputy-Prosecutor, William Jackson. The County Commissioners deem that public interest requires that it be established as a county road to provide public access to the forest boundary. They did, at the December meeting, adopt a resolution declaring this to be their intention and at that time Paul Scherbel was directed to conduct a survey and prepare a plat of the road. The County Attorney has since received written notice, through John Welborn's attorney, that the county will be denied access to the Welborn property for the purpose of conducting said survey. Motion was made by Lois Cobb that the County Attorney proceed with legal steps to obtain a court order authorizing the county to commence and complete the survey. Motion seconded by Bob Tanner and carried unanimously.

Mike Steele asked if there were any further developments regarding the road to the Silver Creek Cemetery and was told that the controversy has been resolved in District Court via a Settlement Agreement. The agreement requires the county to set the fence posts along the designated roadway and notify Mr. & Mrs. Howard Routh in writing when completed. The Routh's will then have thirty days to furnish and place the barbwire, gate and cattle guard.

The Commissioners approved a request made by Stella McKinstry and Eric Peterson that the person who provides the cleaning service in the basement area of the law enforcement center be under their direct supervision and that her salary be included in the agricultural portion of the next fiscal budget.

The following funding requests were heard at various times during the day for consideration at the proposed budget meeting in June:

Dave Dillingham, Pat Nystrom and Bruce Anderson asked that \$10,000.00 be appropriated for the Western Wyoming Mental Health Association this year - an increase of \$2,000.00.

Mary Ann Hansen and Gary Marple asked for \$5,000.00 for the Children's Learning Center - the same as last year.

Chet Peterson, Billy Mitchell, John Coryell and Joe Edwards requested \$12,000.00 on behalf of the Pinedale Volunteer Fire Dept. - an increase of \$3,000. over last year.

Lary Lozier, Barb Richie, Rob Post, Dale Woirhaye and Mike Dermody asked for \$9,000.00, or whatever the county can afford, to be used towards purchase of fire equipment to be utilized in the Boulder community - first request.

Linda Frazier, Jill Tegeler, Miriam Carlson, Gary Neely, Bob Williams, Marlene Wise and Bruce Anderson asked for \$5,000.00 for the Chamber of Commerce - first request.

The Commissioners agreed to a request by Bruce Anderson, Jim Mariner and Bob Sweedler that the Lion's Club be allowed to place a 5' x 10' sign, donated by the town, on county property next to the Chamber of Commerce building.

The First National Bank of Pinedale and the State Bank of Big Piney were designated as depositories of county funds for the ensuing year.

A zoning amendment request by James Meiring, to reclassify 28.18 acres in teh NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 12, T33N., R. 109W. from A-1 to R-R, was approved on motion by Lois Cobb, seconded by Bill Alexander and carried.

A plat of Arrowhead Subdivision was submitted for approval by Attorney Harley McKinney and owners Dick Schmidt and John McCrann. This plat has been approved by the town but has not yet been signed by the town officials. It was moved by Lois Cobb to accept the plat which will be signed by the Commissioners when the following conditions have been met: Plat signed by town officials - easement - easement for right-of-way executed by Harold and Leda Reach and if roads within the subdivision are not completed by that time a performance guarantee will be provided for their construction. Motion seconded by Bill Alexander and carried.

The plat of Big River Subdivision submitted by Attorney Harley McKinney and owner Vic Fulk was not approved.

The plat of Hecox Subdivision, No. Four, owned by Abner and Emma Lou Hecox was approved and signed.

The fees for county retail liquor and malt beverage licenses were considered by the Board. Statutes provide the minimum and maximum fee which is \$500.00 and \$3,000.00 for Retail and Restaurant licenses and \$100.00 and \$1,500.00 for Malt Beverage Permits. Lois Cobb moved to increase all fees, which are now at the minimum, by 25%. Retail and Restaurant Licenses to \$625.00 and Malt Beverage Permits to \$125.00 Motion seconded by Bill Alexander and carried.
