



OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
May 19, 1980

A special meeting of the Sublette County Board of County Commissioners was called to order at 7:30 pm on this date by the chairman, C. F. Alexander, with Members Lois Cobb and W. R. Tanner present. Others attending the meeting were Bill Jackson, Ric Samulski, Paul Scherbel, Leo Schueler, Marlenn Wise, and Janet Montgomery.

There was a discussion of the problems the county is having enforcing state and county subdivision regulations. Bill Jackson was asked to write Victor Fulk regarding complying with county road standards. Janet Montgomery is to prepare a letter for County Commissioners to County Attorney requesting he take appropriate legal action against Elvin Booth & Victor Fulk as they have both sold land which was unplatted as though that land were a part of a platted and recorded subdivision.
