

The one application for Restaurant Liquor License, by White Pine Lodge and Ski Area was again denied by the County Commissioners on motion by Bob Tanner, seconded by Lois Cobb and carried. Their reasons included the recent change of ownership and the lack of evidence concerning it's financial stability. The Commissioners decided not to issue the Restaurant Liquor License until after the 1980 census has been completed after which all interested persons will be advised, by advertising, that applications for the license will again be considered.

Judy Bogle and Sharon Grant, of the Pinedale Children's Center, made a budget request for \$5,000.00 or less if necessary to help meet the energy problems at the Center. This request will be considered when the preliminary budget is reviewed.

Fred Peterson asked the possibility of having the county grade the first three miles of road to the Boulder Lake Ranches. The Commissioners will check the status of the road and advise him of their decision.

Attorney Pat Mattimoe and Arthur Trotta were present to discuss a platted road in the Big Country Ranches Subdivision (Fourth Filing) which has not yet been constructed. Mr. Trotta told the Board that the road would divide the two lots which he owns and would interfere with irrigating all his property. The Commissioners have no objections to the road being deleted since all lots within the subdivision will still have the required access. Mr. Trotta was advised to obtain written agreement from the other lot owner involved and have Mr. Fulk submit an amended plat reflecting the deletion of the road.

On motion by Bob Tanner a Resolution was adopted that the county apply for permit to drill a well on land patented to it under the Recreation and Public Purposes Act for county fair ground purposes and also to provide a second baseball diamond at the same site. Motion seconded by Lois Cobb and carried unanimously.

The Board accepted the written resignation of Janet Montgomery as County Zoning Administrator effective July 1, 1980. At their request Mrs. Montgomery agreed to remain until August 1 to help train the new administrator, when hired.

Commissioner Tanner made a motion, seconded by Commissioner Cobb and carried, that the following election officials be appointed as judges and alternates for their respective precincts for a two year term:
