Campaign Filing Requirements

All candidates, whether successful or not, must file a statement of receipts and expenditures by September 19th. A candidate must file the statement before receiving a certificate of nomination or election.

Every candidate's campaign committee and political action committee shall file a statement of campaign receipts and expenditures by September 16th.
