

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
July 21, 1980

The public hearing of the 1980-81 fiscal budgets for Sublette County and the independent political subdivisions was held this date at 8:00 p.m. as advertised.

Present: Commissioners C. F. Alexander, Lois E. Cobb and William R. Tanner, Clerk, Lois J. Yake, Home Demonstration Agent Stella McKinstry; Weed & Pest Control Board Treasurer, Wayne Feltner and Upper Green River Cemetery Sexton, Bob Carlson.

At the preliminary budget meeting the commissioners lowered the Weed & Pest budget by \$25,775.00 largely based on amounts requested by Supervisor Les Burroughs as compared to amounts recommended by the board members. Mr. Feltner felt that the amounts allowed for additional labor and insecticides were not sufficient and the commissioners agreed to increase these two items by \$5,000.00 and \$2,000.00 respectively a total budget of \$101,100.00.

Bob Carlson explained that the figures entered in the Upper Green River Cemetery budget as last years expenses for gas and oil and mileage were actually the remaining balance and that they had failed to deduct the depreciation reserve fund and unpaid bills from the cash on hand. After making the necessary additions and corrections this budget was approved at \$46,645.00.

The Hospital budget was again considered and the following changes made:

\$80,000.00 deleted from the construction portion of the Capital Outlay Budget,


\$20,000.00 added to the Plant Operation Budget.


\$20,000.00 added to Depreciation Reserve Funds for building improvements.


The final figure approved for this budget is \$235,364.00.

The Board of County Commissioners met this date with all members and their clerk present to finalize the 1980-81 fiscal budget.

On motion duly enacted the following resolutions were adopted:

APPROPRIATION RESOLUTION

WHEREAS, on the 13th day of June, 1980, Lois J. Yake, County Clerk the budget making authority, prepared and submitted to the Board a county budget for the 1980-81 fiscal year ending June 30, 1981

WHEREAS, such budget was duly entered at large upon the records of this Board and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Pinedale Roundup a legal newspaper published and of general circulation in the county on the 26th day of June, 1980, and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in such proposed budget, all of which more fully appear in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the fiscal year ending June 30, 1981

BE IT FURTHER RESOLVED, that the following appropriations be made for the 1980-81 fiscal year ending June 30, 1981 and that the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.
