OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
September 9, 1980

A special public meeting of the board of commissioners was held this date at 3:30 p.m. for the purpose of hearing objections and considering claims for damages relating to the establishment of the Binning Road No. 23-185 as a county public road.

Present: Chairman C.F. alexander, Commissioners Lois E. Cobb and W. R. Tanner, Clerk Lois J. Yake, County Attorney Robert Sievers, Deputy County Attorney William Jackson, Stanley Murdock and Attorneys Gerald Mason and William Twitchell, Larry Looney and Attorney John Mackey, Joella Dugan, Josephine Binning and Burleigh Binning.

After considering several letters protesting the establishment of the above road as a public county road and hearing the objections and claim for damages presented by Attorney Mason on behalf of his client Stan Murdock, motion was made by Bob Tanner as follows: "In view of the discussions and presentations had at this hearing, and considering the objections filed, the potential cost to the county and the recommendations of the viewer, I move that the county take no further action to make the road in question a county public road." Motion was seconded by Lois Cobb. Voting aye: Commissioners Tanner and Cobb. Motion duly passed.

There being no further business before the board the meeting adjourned at 4:45 p.m.
