

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
January 5, 1982

The Board of County Commissioners met this date in regular session at 9:00 a.m. with Chairman C. F. Alexander, Members W. R. Tanner and Floyd E. Bousman and County Clerk Lois J. Yake present.

The minutes of December meetings were approved as published in the Pinedale Roundup.

A Tax Reduction Order was approved for Ruth E. Dixon, et al in the amount of \$15.64.

A request by Chuck McCarty, for new tires and repair of the county-owned snow-cat use by search and rescue units, was approved for an estimated cost of \$1800.00.

Bucky Neely met with the board to determine if the Pinedale Airport Board is subsidizing Ken Smith by allowing him to conduct his snow machine business from the hanger at the airport and who owns the equipment he is using in that business. The commissioners agreed to discuss the matter with the airport board. Chuck McCarty stated that, in his opinion this was not so. While he was operating the airport he paid the airport board an annual fee for use of the hanger, block building and space for a mobile home plus a set amount for each gallon of fuel pumped. In order to have Mr. Smith available fulltime as airplane mechanic, even though it was not a full-time job, he allowed him to supplement his income by operating his snow machine business from the hanger. He said that Mr. Smith owns the equipment and that the contract between the airport board and the new operator is basically the same so if anyone is subsidizing Mr. Smith it must be the operator since he is leasing the hanger.

A letter from the Wyoming Recreation Commission requesting transfer of the county's share of 1980-81 snowmobile registration fees, in the amount of \$1525.00, to the agency for maintenance of snowmobile trails in Sublette County was approved on motion by Floyd Bousman. Motion seconded by Bob Tanner.

Rod Bennett was re-appointed to serve an additional five year term on the Big Piney Airport Board commencing January 30, 1982 on recommendation by the Big Piney town council.

As approved by the Pinedale town council, Craig Crandall was appointed to the Pinedale Airport Board for a term of five years to succeed Horace Swain whose term expires 1-30-82.

Mr. & Mrs. Jim Brown, Mr. & Mrs. Joe Hay, Mr. & Mrs. Forrest Grossman and Roger Anderson, lot owners and developer Joe Hicks attended the meeting to request snow removal in the Redstone-New Ford Subdivision. The commissioners explained that since this is not a duly established county road it cannot be maintained by the county. They concurred with Mr. Hicks comment that they had earlier agreed to take this as a county road but only when the majority of lots are sold and occupied. Presently there are five homes completed and one started. They were advised to initiate the procedure for establishing this as a county road by submitting a road petition containing the required number of signatures.

Director Gay Rogers and members of the Sublette County High Country Senior Citizens Center attended the meeting to request financial aid. They have used the \$20,000.00 state grant plus all donations for remodeling and furnishing the old clinic and to construct the outside walls of an 18' X 44' addition to the building. They have one outstanding bill of \$4373.51 and estimate a cost of \$10,650.00 to finish the new addition plus \$4740.40 in matching funds for the grant to provide meals and services to senior citizens for the current fiscal year. On motion by Mr. Bousman they will be allowed to use \$20,000.00 of funds allocated to the retirement center, to provide services to non-residing senior citizens, since it is not likely that the center will be completed and operating during the current fiscal year and to replenish that amount in the next years budget. Motion was seconded by Mr. Tanner and carried unanimously.

Members of the rural television committee related that Bob Smith, operator of Cable West Television failed to provide rural T.V. reception as agreed and was instructed to return all equipment back to the committee. There is no money available to repair and upgrade this equipment & research has indicated that the best method of obtaining another signal and providing reception to all areas of the county is by installing satellite reception dishes on Ross and Cora Buttes. They asked the county to help with at least the initial cost of the dishes estimated at \$40,000.00. Because this amount is not available in the current budget they were encouraged to seek donations from rural viewers as a first step in acquiring the necessary equipment. It was brought out that some counties do appropriate funding for rural television and this possibility will be explored prior to next years budget hearings.

Application for transfer of County Retail Malt Beverage Permit from Willard E. Smith, dba Hoback Village to Dennis L. Kirkwood, dba Hoback Village was approved on motion by Floyd Bousman, seconded by Bob Tanner and carried. Permit expires July 1, 1982.
