R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Sublette County deem the public interest requires that a road be established in accordance with Wyoming Statutes, 1977, as amended, Section, Section 24-3-108, to be known as PROFIT COUNTY ROAD NO. 23-201 described as follows:

BEGINNING at Station 2+14.6 on the east line of Section 36, T33N, R113W, N00°-09'W, 3100.59 feet from the southeast corner of said Section 36; thence Westerly through the SE<sup>1</sup>NE<sup>1</sup>, SW<sup>1</sup>NE<sup>1</sup>, NW<sup>1</sup>NE<sup>1</sup>, NE<sup>1</sup>NW<sup>1</sup> and NW<sup>1</sup>NW<sup>1</sup>, and

terminating on the west line of said Section 36, S00°-01'E, 747.5 feet from the northwest corner of said Section 36; and

WHEREAS, a right-of-way easement had been granted by the Commissioner of Public Lands for public land of the State of Wyoming lying within this roadway; and

WHEREAS, the official linen plat consisting of one sheet this road is filed in the Office of the Clerk of Sublette County; and

WHEREAS, the Board of County Commissioners has agreed to abide by the stipulations of said easement as enumerated by the Commissioner of Public Lands; and

WHEREAS, the designation of this roadway is a courtesy to the owners of lands in Section 35 to provide access thereto and that the owners of said lands agree to abide by and comply with the said stipulations and further, that the County is not obligated to nor will it maintain the said roadway;

NOW, THEREFORE BE IT RESOLVED, that the PROFIT COUNTY ROAD NO. 23-201 described above, be and is hereby declared a public County Road.
