their date or dates and to be issued and sold on such lawful terms and conditions as the Board may determine, including provisions for the redemption of bonds prior to their respective maturities at or above par?

Paper Ballots shall be used for the special bond election and the election shall be held in the manner prescribed by the Wyoming Election Code.

The boundaries and polling place of which shall be the same as those used in the statewide general election, as follows:



No person shall be permitted or qualified to vote at the bond election who is not a qualified elector. The term "qualified elector" includes every citizen of the United States who is a bona fide resident of the State of Wyoming, The County of Sublette and has registered to vote therein and will be at least 18 years of age on the date of the election. Any person who is otherwise a qualified elector but who has within the 10 days immediately preceding the election moved his or her residence to another precinct within the County shall not thereby become disqualified to vote in the precinct out of which he or she has moved. No person shall be a qualified elector who is an idiot or insane person, or who has been convicted of a felony, unless (in the case of a felon) he or she was subsequently restored to civil rights. A literacy test shall not be imposed as condition to voting at the election.

Any person who expects to be absent from his or her place of residence on election day, or who cannot be present at his or her precinct polling place on election day because of illness, injury, disability, old age or tenets of his or her religion, may apply for an absentee ballot in person, in writing, or by telephone at the office of the County Clerk, Sublette County Courthouse, Pinedale, Wyoming. A qualified elector may apply for an absentee ballot up to the day of election.

Section 14. Immediately after the closing of the polls the election officers shall proceed to canvass the ballots. The results disclosed by such canvass shall be immediately certified by the election officers to the County Clerk. If the majority of the ballots cast at the election favor the issuance of the bonds, the proposal shall have carried, and the Board of County Commissioners in the manner provided by law, shall then proceed to declare the results of the election, and complete the printing, execution, advertisement and sale of the bonds.

Section 15. All consistent action taken by the Board of County Commissioners directed toward:

- A. The calling of a bond election on July 13, 1982, and the giving of notice thereof; and
- B. The issuance of its general obligation bonds for the purpose set forth above, is ratified, approved and confirmed.

Section 16. The officials of the County are authorized and directed to take all action necessary or appropriate to effectuate the provisions of this resolution.

Section 17. All acts, orders or resolution, or parts thereof, in conflict with this resolution are repealed.

Section 18. If any provision of this resolution shall be held to be invalid or unenforceable, the invalidity or unenforceability of such provision shall not effect any of the remaining provisions of this resolution.
