

On motion by Commissioner Tanner, seconded by Commissioner Bousman and carried, the following resolution was passed:

R E S O L U T I O N

WHEREAS, Section 18-3-107, Wyoming Statutes, 1977, amended by Session Laws of 1981, provides that the County Commissioners of each County in the State of Wyoming shall meet not later than June 1, 1978, and on or before the same date each four (4) years thereafter, for the purpose of setting the salaries for County Assessor, County and Prosecuting Attorney, County Clerk, Clerk of District Court, County Sheriff and County Treasurer; and

WHEREAS, Said Section 18-3-107, Wyoming Statutes, 1977, also provides that the Board of County Commissioners shall meet not later than June 1, 1978, and on or before the same date each four (4) years thereafter for the purpose of setting their salaries for the following four (4) years commencing January 1; and

WHEREAS, having been duly deliberated and discussed the various factors which are determinative of said salaries and said salaries having been approved by the Board of County Commissioners it is the desire of the Board of County Commissioners of Sublette County, Wyoming, to now set said salaries by Resolution.

WHEREAS, Section 5-4-205, Wyoming Statutes, 1977, as amended by Session Laws of 1981, provides that the Board of County Commissioners shall set the salaries of Justices of the Peace in their respective counties within the maximum salaries set forth and in accordance with the provisions of Wyoming Statute 18-3-107; and

NOW, THEREFORE, BE IT RESOLVED, That the County Assessor, County Clerk, Clerk of District Court, County Sheriff and County Treasurer of Sublette County, Wyoming, shall receive an annual salary of \$25,000.00 for the calendar year 1983, \$26,500.00 for the calendar year 1984, \$28,000.00 for the calendar year 1985 and \$29,500.00 for the calendar year 1986. In addition to said monetary compensation, the said elected officers of Sublette County, Wyoming shall receive the same benefits accorded to other full-time employees of Sublette County, Wyoming, at the date of the adoption of this Resolution, including but not limited to the same member contributions and matching contributions from the County to the Wyoming Retirement System as other full-time County employees, and the same coverage under any County Insurance policies at the rates accorded other full-time County employees.

BE IT FURTHER RESOLVED, that the County and Prosecuting Attorney shall receive an annual salary of \$45,000.00 the maximum allowed by Statute for each year of the four year term commencing January 1, 1983.

BE IT FURTHER RESOLVED, That each of the County Commissioners, with an effective term commencing January 1, 1983, shall be compensated in the amount of \$2400.00 annually. In addition each County Commissioner shall receive \$50.00 for each meeting, other than the one regularly scheduled monthly meeting, in any given month.


BE IT FURTHER RESOLVED, That elected Justices of the Peace, Sublette County, Wyoming shall receive an annual salary of \$12,000.00 for the four-year term commencing January 1, 1983.


BE IT FURTHER RESOLVED, That the salaries herein established shall not be changed during the four-year term of said elective officers.


