

Alexander and Bousman stated that it would be approved and said they were not against county funding for the project so long as it was obtained in a legal manner. It was decided to pursue this course and Deputy County Attorney Bill Jackson offered to donate his time to help them so they won't have the added expense of hiring an attorney.

An application for variance by R. T. Fisk, for a planned unit development on the property known as Hoback Basin Guest Ranch near Bondurant, was approved by the commissioners for a period of one year. Mr. Fisk will be required to submit plans for the commissioners approval prior to any on site construction.
