


OFFICIAL MINUTES

Pinedale, Wyoming
August 10, 1982

The Board of County Commissioners, County of Sublette, met in special session on this date at 2:00 p.m. with chairman C. F. Alexander and member Floyd E. Bousman present.

Having been advertised in the Pinedale Roundup on July 8 and August 5, 1982, public hearings were held on the following:

1. It was moved by Commissioner Bousman that the Board approve the final plat of Energy Industrial Park Subdivision. The water deed to the Town of Granger is to be recorded with the plat. A \$20,000.00 certificate of deposit payable to Sublette County was accepted as bond for the building of roads. Chairman Alexander seconded the motion and upon vote it was carried and passed.
2. It was moved by Commissioner Bousman that the Board accept and act upon the recommendations made by the Planning and Zoning Commission. Chairman Alexander seconded the motion and upon vote it was carried and passed, and the following resolution was adopted:
