

## OFFICIAL COUNTY COMMISSIONERS PROCEEDING

Pinedale, Wyoming  
October 5, 1982

The Board of County Commissioners met in regular session at 9:00 a.m. with C. F. Alexander, Chairman, W. R. Tanner and Floyd E. Bousman, Members and Lois J. Yake, clerk present.

Minutes of the September 7th meeting were approved as published on motion by Floyd Bousman, seconded by Bob Tanner and carried.

The official bond of Jay McClain as Treasurer of the Pinedale Airport, in the amount of \$1000.00 was approved and filed with the County Treasurer.

Ron Lovercheck, Maicille Carr, Big Piney Council Member, and Sue Hoefer, Marbleton Council Member, asked the County Commissioners to join the towns in supporting the optional 1% sales and use tax proposition to be voted on in November. The three incorporated towns have endorsed the measure and earmarked the funds, if passed by the voters, for street improvements in Pinedale and Marbleton and sewer and street improvements in Big Piney. The Commissioners agreed to lend their support and stated that the county's share would be used for the fire departments, airports and for rural television, through a recreation board, if it could be accomplished legally. They also discussed the possibility of using some of the funds to provide financial support for town operated sanitary landfills.

The Commissioners approved a request by Craig Georgeson, zone sales manager for Motorola C & E, to share space on the county's radio tower, located on Mt. Airy, for a community repeater operating on a different frequency than used by the county.

The County Commissioners directed a letter to Governor Ed Herschler nominating Paul Scherbel for appointment to represent district #3, for a six year term, on the Highway Commission commencing February 1, 1983.

Green River Subdivision owners Linda and Ed Dickerson, Emma and Michael Bromley, Judy Profit and Rusty Thomas attended the meeting to protest alledged violation of the county's zoning resolution by Marvin Bowers, owner of Lot 14 of the subdivision. They presented a photograph showing a drilling rig stacked on the property and listed dates and times when drill pipe had been delivered to the site. They stated that the zoning laws were not being enforced and asked the county to take action. After further discussion the Commissioners reached a dicision to gather evidence of the violations, if any, and to take the necessary steps to stop existing and future violations.

Floyd Bousman moved to provide funding in the 1983 or 1984 county budget to help finance a new fire truck for the Pinedale Volunteer Fire Department. Motion seconded by Bob Tanner and carried unanimously.

The county entered into a lease/purchase agreement for computer equipment with Data Management Systems on motion by Floyd Bousman that the county lease the equipment till the end of the fiscal year and evaluate its affectiveness at that time prior to extending the lease on an annual basis. Motion seconded by Bob Tanner and carried. The programs have been developed exclusively for county government and are now in use in Big Horn, Johnson and Uinta Counties. They will be used by the assessor, treasurer and clerk for payroll, taxroll/assessment, budgetary accounting, official records and other programs as they are developed by Data Management Systems. All training will be on site.
