

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
January 4, 1983

The Board of County Commissioners met in regular session at 9:00 a.m. with all members and their clerk present. Floyd Bousman was elected Chairman of the Board on motion by Louie Tomassi. Motion seconded by Gordon Johnston and carried.

Minutes of the December meeting were approved and published on motion by Commissioner Tomassi, seconded by Commissioner Johnston and carried.

Official Bonds approved and filed: Lois J. Yake, County Clerk - \$4000.00; Nylla Kunard, County Treasurer \$100,000.00; Hazel Werner, County Assessor - \$5000.00; Ellen L. Neely, Clerk of Court - \$10,000.00; William W. Cramer, Justice of the Peace - \$1500.00 and Lois Cobb, Secretary-Assistant Treasurer, Sublette County Recreation Board - \$10,000.00.

Commissioner Tomassi moved that the Board also meet on the third Tuesday of each month. Commissioner Johnston provided a second to the motion which carried unanimously. It was agreed that the first Tuesday of each month will be devoted to routine county business and the third Tuesday will be used to meet with concerned citizens, attend to the zoning matters and inspect roads with the road and bridge foreman if time permits. They will also be available on the second and fourth Tuesdays, if requested, to meet with county employees or boards.

On motion by Commissioner Johnston the Commissioners will announce their intent to form a county-wide Solid Waste Disposal District and advertise for volunteers to serve as appointees to a five member board for the purpose of determining the most feasible means of handling solid waste problems. Motion seconded by Commissioner Tomassi and carried.

On motion duly established the following board appointments were made: Kenneth Shriver re-appointed to four year term on the Weed & Pest Control Board. Joe Boroff appointed to a four year term on the Weed & Pest Control Board. James Mariano appointed to a five year term on the Pinedale Airport Board. Appointment of a member to the Big Piney Airport Board was tabled until the next meeting.

County Attorney Bill Jackson stated that, for audit purposes, he wished the minutes to reflect that approximately \$280.00 paid by the county as government rate for the copy machine used in his office prior to January 3rd has been offset by budgeted expenses personally paid by him prior to that time. He will furnish verification on these expenses to the county clerk.

Les Burroughs, Weed & Pest Administrator, stated that his board has decided not to construct an office and equipment storage building on county property where the county shop is located, as planned, due to the high water table in that area. He mentioned that the State Highway Department is planning construction of new shop facilities sometime within the next three years and the old buildings, on approximately nine acres, will be sold to the highest bidder or may be available to the county for the appraised valuation of somewhere around \$100,000.00. The Commissioners recommended finding other storage facilities until the property becomes available and re-allocating the \$40,000.00 set aside in the Weed & Pest budget for new construction, towards its purchase. The Commissioners asked the county clerk to advise the Highway Commission, by letter, of the county's interest in acquiring the property if and when it becomes available.

On motion by Commissioner Johnston, seconded by Commissioner Tomassi and carried, the following resolution was adopted:

R E S O L U T I O N NO. 83-1B

A RESOLUTION ACCEPTING RIGHT OF WAY EASEMENTS ON THE NEW FORK-WILLOW CREEK COUNTY ROAD NO. 23-120 FROM JOHN B. WELBORN, AND DECLARING INTENTION TO ABANDON ESTABLISHMENT OF A PORTION OF THE ROAD NOT INCLUDED IN THE EASEMENTS, AND COUNTY ROAD NO. 12.

WHEREAS, under two instruments dated January 3, 1983, John B. Welborn granted right-of-way easements to the County of Sublette covering portions of the New Fork-Willow Creek County Road No. 23-120, in compliance with the terms of an agreement between the County entered into on September 9, 1982.

WHEREAS, in consideration for said easements, the County agreed to abandon any attempt to establish a county road beyond the Irv Lozier ranch turn-off, and to abandon County Road No. 12, which is not in use.

Whereas, at a regular meeting of the Board of Commissioners of Sublette County, Wyoming, said right-of-way easements were accepted, and it was agreed, upon proper motion and vote that abandonments as aforesaid would be undertaken.

NOW, THEREFORE:

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLETTE COUNTY, WYOMING:

1. That the County shall desist from attempting to establish a county road on that portion of New Fork-Willow Creek road beyond the turn-off to the Irv Lozier ranch.

2. That the County shall undertake proper proceedings to abandon County Road No. 12.
