

Howard Smith, representing the Sublette County Retirement Center, told the Board that St. John's Hospital, in Jackson, has made application to the state for a certificate of need to expand the permanent nursing home wing of the hospital by thirteen beds to accommodate a total of 25 occupants. He explained that the nursing wing here at the retirement center is currently at 50% of occupancy and they were required to prove that all other nursing homes in the surroundings area had waiting lists before their certificate of of need was granted by the state. He stated that a larger Jackson facility would threaten the economic viability of the local facility. The Commissioners agreed to direct a letter to the Division of Health and Medical Services opposing expansion of the Jackson facility until the local nursing home has reached full capacity.

Carl Ingersol, Social Services Director, asked the Commissioenrs to consider enlarging the county-owned social services office to accomodate another employee being sent by the state to assist on a part-time basis. The Commissioners told him that they are exploring the possibility of utilizing unused space in the basement of the law enforcement center and offered to remodel and rent space to D-PASS if the area is large enough. After looking at the area Mr. Ingersoll returned to say that it would be adequate and will arrange for someone from the state office to meet with the Commissioners.
