As the county has been unable to secure road right-of-way easements through normal procedures, Commissioner Johnston moved that the county give notice that adverse possession procedures will commence March 1, 1983, for the Pinedale South County Road No. 23-123 and Boulder Lake County Road No. 23-125. Commissioner Tomassi seconded the motion and upon vote it was carried and passed, and the following resolutions were adopted:

## RESOLUTION NO. 83-11B

WHEREAS, the Board of County Commissioners of Sublette County deem the public interest requires the establishment of Pinedale South County Road No. 23-123;

WHEREAS, the Board of County Commissioners of Sublette County has been unable to secure a right-of-way easement from F. J. and Christine Mollring, David E. Shaffer, Lucius B. and Malynda H. Morgan;

WHEREAS, the aforesaid road has been surveyed and platted;

NOW, THEREFORE BE IT RESOLVED, the Board of County Commissioners, County of Sublette, will initiate the procedure to obtain part of said road through adverse possession in accordance with Wyoming Statutes, 1977, as amended, Section 24-1-101, at the regular meeting of said Board on March 1, 1983.
