

Pinedale, Wyoming
March 15, 1983

The Board of County Commissioners, County of Sublette, met in regular session on this date at 1:00 p.m. with chairman Floyd Bousman and members Gordon Johnston and Louie Tomassi present.

Having been advertised in the Pinedale Roundup on March 10, 1983, public hearing was held for the following:

1. Variance request by W. L. Bain and Barbara Bain to allow overhead power line across Jim Bridger Estates Subdivision. The Commissioners stated that they had no objection to the variance but were concerned that the property owners in the subdivision did not object. Tomassi moved that the application be tabled until written consent is received from the property owners in Jim Bridger Estates. Johnston seconded the motion. Motion carried.
2. It was moved by Commissioner Johnston that the Board accept and act upon the recommendation made by the Planning and Zoning Commission. Commissioner Tomassi seconded the motion and upon vote it was carried and passed, and the following resolution was adopted:





There being no further business, the hearing was adjourned.


