WHEREAS, the Board of County Commissioners, Sublette County, Wyoming, has on the 15th day of February, 1983, resolved to obtain by adverse possession in accordance with Wyoming Statutes, 1977, as amended, Section 24-1-101, the right of way for the PINEDALE SOUTH COUNTY ROAD NO. 23-123 across the following described lands owned by F. J. and Christine Mollring, David E. Shaffer, Lucius B. and Malynda H. Morgan:

Commencing at the East Quarter Corner of Section 4, T33N, R109W, Thence running Southerly 750 feet; and Commencing at the West Quarter Corner of Section 10, T33N, R109W, Thence running Northerly, 2010.59 feet; and Commencing at a point which bears S00°-25'-28"E, 331.30 feet from the southeast corner of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 9, T33N, R109W, thence Southerly, 331.30 feet.

NOW, THEREFORE, BE IT RESOLVED, that said right of way is hereby established.
