

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
May 3, 1983

The Board of County Commissioners met an hour before their regularly scheduled meeting time to open bids for the construction of a maintenance building at the county fair grounds. Present: Chairman Floyd Bousman, Members Gordon Johnston and Louie Tomassi and County Clerk Lois Yake.

Ten building contractors submitted bids each containing one or more of the various options contained in the bid invitation published in the PINEDALE ROUNDUP on April 14th and 21st. The decision for accepting or rejecting any or all bids was tabled until the next regular meeting on May 17th to allow ample time for reviewing all bids.

The regular meeting was called to order at 9:00 a.m. by Chairman Bousman. Moved by Commissioner Johnston, seconded by Commissioner Tomassi to approve the minutes of the April 19th meeting as published in the Pinedale Roundup. Motion passed.

Millie Pape asked the commissioners to appropriate \$1000.00 for the Sublette County Sexual Assault and Family Violence Task Force in the upcoming county budget and also requested a letter of support to accompany their application for state funding. The commissioners gave tentative approval to the budget request and directed their clerk to prepare a letter of support.

President Ike Walton, Director Laurie Hartwig and members John Mortensen and Ken Konicek made a budget request of \$1500.00 on behalf of the Pinedale Area Chamber of Commerce which will be considered by the commissioners during budget preparation. Their requests have not been approved in prior years and Commissioner Johnston stated that he was not in favor of raising the mill levy for things like chamber financial assistance.

Lorita Overbeck and Gerry Chase of Big Piney and Rance Meyers of Pinedale were selected to receive the County Commissioners Scholarships for the 1983-84 academic year. The scholarships provide a waiver of tuition to the University of Wyoming or any two-year community college in the state. The one renewal scholarship was awarded to Jim Olson of Big Piney. Considerations for receiving the scholarships are individual need, character, and extra curricular activity and scholastic ability.

Pinedale Mayor Chuck MacIlvaine, Administrator Bruce Edwards and Council Members Doris Burzlander and Ralph Stevens were present at the commissioners invitation to discuss financing of a new fire truck for the Pinedale Volunteer Fire Department. Commissioner Tomassi explained that two years ago the county commissioners had agreed to help finance a new fire truck for the Big Piney Volunteer Fire Department in the amount of \$25,000.00 a year and must also allocate monies for the Bondurant and Boulder units so they may not approve the total \$55,000.00 requested by the Pinedale department. He inquired if the town could increase its \$20,000.00 allocation to the fire department to help make the downpayment on the truck. Mayor MacIlvaine replied that this may have been possible before the town's new budget became effective in late April but it cannot be altered now. It was suggested that the town could use funds budgeted to the fire department towards the downpayment and be reimbursed when county funds become available, however the town was reluctant to go this route since that department's operating funds would be tied up until the first major portion of county taxes are collected and disbursed in December. After further discussion Commissioner Tomassi moved that county allocations to the Pinedale Volunteer Fire Department be \$25,000.00 a year, for four years, excluding the Bondurant and Boulder units. Motion was seconded by Commissioner Johnston and carried.

The following resolutions were adopted on motions duly established:

Resolutions declaring the PINEDALE SOUTH COUNTY ROAD NO. 23-123, the NEW FORK WILLOW CREEK COUNTY ROAD NO. 23-120, the BOULDER LAKE COUNTY ROAD NO. 23-125, and the UPPER HOBACK RIVER COUNTY ROAD NO. 23-174 as public county roads.
