

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
August 16, 1983

The board of County Commissioners met in regular session this date at 9:00 a.m. Present: Commissioners Floyd Bousman, Gordon Johnston, Louie Tomassi and County Clerk Lois Yake.

The meeting was called to order by Chairman Bousman and the minutes of the previous regular meeting were read. There being no additions or corrections the minutes were accepted and filed as read.

Dr. Andy Turner, Administrative Director of Western Wyoming Mental Health Association and Michael Cain, Director of the Sublette County Mental Health Center provided a monthly activity and progress report concerning the mental health program. The also submitted, for the commissioners consideration and recommendation, the names of four county residents who are willing to serve on the regional mental health board of directors. After due deliberation the commissioners recommended that Ed Wood and Sylvia Schaffer be appointed to serve on the board commencing in September.

It was moved by Commissioner Johnston that the county treasurer be authorized to remove property involved in bankruptcy proceedings from the delinquent tax roll described as follows: Lots 13, 14, 15 & 16, Block 39, Marbleton assessed to Gerald Wilder and Gail Wilder dba Sublette Lumber. The county treasurer is not to place the property back on the tax roll until the bankruptcy is discharged or until the property has been deeded to someone else through bank ruptcy proceedings. Motion seconded by Commissioner Tomassi and carried.

Following a discussion of the contracts between the hospital board and the doctors, Commissioner Bousman made a motion that no payments be made on the contracts by the hospital board until the attorney has said that such payments are legal. The motion died for lack of a second. County Attorney Bill Jackson was instructed to submit copies of the two contracts to the attorney general for consideration.

John Frullo, architect and Neil Dixson, contractor explained various options which the county may employ in the construction of the courthouse addition. It is anticipated that the plan will be advertised for bid upon completion of the structural engineering phase.

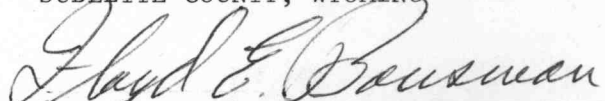
Esther Bolinger asked the commissioners to consider a county-wide aerial spraying program for next spring. Louie Tomassi stated that Les Burroughs, weed and pest supervisor can obtain a safe, effective chemical for such a project but the cost would be prohibitive. The total three mills which can be levied by the Weed and Pest Control District would probably not be enough to provide effective county-wide coverage and the percentage of that budget which can be allocated for mosquito abatement is limited by law.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

August 23, 1983

The Board of County Commissioners, meeting informally this date, voted to call a special meeting for official transaction of urgent business. In so voting they waived any and all requirements imposed by law for the calling of special meetings.

The business deemed to be of urgent nature was as follows:

1. Contracts with medical clinics
2. Signing of two deeds for the county recreation board

Commissioner Tomassi moved to accept the operating contracts between the hospital board and both clinics, one as submitted by Attorney John Mackey, on behalf of Dr. Close and the other a contract previously entered into between the hospital board and Dr. Johnston. Commissioner Johnston seconded the motion. Chairman Bousman asked the County Attorney Bill Jackson if he had examined the contract submitted by Attorney Mackey. The County Attorney replied that he had not. Chairman Bousman then called for a vote on the motion. Voting aye: Commissioners Tommassi and Johnston. Voting nay: Chairman Bousman. Motion carried.

The deeds for property donated to the county for golf course purposes were approved and signed by the commissioners.

There being no further urgent business before the board the meeting was adjourned.
