


OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
September 6, 1983

The Board of County Commissioners met in regular session at 9:00 a.m. with Chairman Floyd E. Bousman, Members Gordon Johnston and Louie Tomassi and County Clerk Lois J. Yake present.

Minutes of the previous regular and intervening special meeting were read. There being no additions or corrections the minutes were accepted and filed as read.

The commissioners and architect John Frullo executed an owner-construction management agreement designating Dolence & Frullo Architects, of Rock Springs, as construction managers for the courthouse addition. Their fee as manager will be 7% of the total cost. They will also receive 7% for their architectural services. Mr. Frullo indicated that they are ready to advertise for bids for the basement portion of the addition.

Chairman Earle Crandall related that the county Recreation Board is planning to advertise for bids for completion of the golf course using funds derived from the sale of lots and possibly the \$50,000. grant received of the Wyoming Recreation Commission.

Commissioner Tomassi restated his August 23rd motion to accept the operating contracts between the hospital board and both clinics. Commissioner Johnston again seconded the motion. Voting aye: Commissioners Tomassi and Johnston. Voting nay: Chairman Bousman. Motion carried.

On motion duly established the following resolution was adopted:

RESOLUTION NO. 83-50B

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE BUTLER FINDLAY HYDRA SCREEN (GRAVEL SHAKER) AND THE FINANCING OF SUCH PURCHASE THROUGH A BANK. As recorded in Book 1 of Resolutions Page 354.

A request by the Wyoming Highway Patrol to utilize the county building, formerly occupied by the Department of Public Assistance, as office space was approved on motion by Commissioner Johnston. Motion seconded by Commissioner Tomassi and carried.

The commissioners considered the dues and assessment schedule, received of the Pine Creek Ditch Association, for irrigation water on county shop property. It was determined that the county has no need for such water and the clerk was instructed to research the legal procedure for releasing the county's water right.
