


RESOLUTION NO. 83-53B

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
October 4, 1983

The Board of County Commissioners met in regular session this date with Commissioners Floyd Bousman, Gordon Johnston and Louie Tomassi and County Clerk Lois Yake present.

The meeting was called to order at 9:00 a.m. by Chairman Bousman and minutes of the previous regular meeting were read. There being no additions or corrections the minutes were accepted and filed as read.

The commissioners selected Louie Tomassi to represent the Board at meetings scheduled by Exxon Company to review the Exxon industrial siting permit data for the proposed Riley Ridge Project. Four meetings are scheduled for October and will also be attended by representatives of Lincoln County, Kemmerer, Diamondville, Opal, LaBarge, Big Piney and Marbleton. Topics to be covered include employment forecast, housing and labor availability, population distribution, Exxon's commitment to support projects eligible for grants and loans and to review draft environmental and socioeconomic chapters of Exxon's Industrial Siting Application and list of human service and public facilities needed to meet projected population.

On duly established motion the following resolution was adopted:

RESOLUTION NO. 83-53B - APPOINTING THE MEMBERS OF THE SUBLINTE COUNTY YOUTH DIVERSION COUNCIL AS MEMBERS OF A JUVINILE PLANNING COMMITTEE, WITH THE POWER AND AUTHORITY TO ACT IN ACCORDANCE WITH COMMUNITY SERVICES FOR YOUTH LEGISLATION. The committee will formulate a plan to provide services to troubled youth and make application for state funds allocated for such services.

Bids for the basement portion of the courthouse addition were opened and read aloud:

Bid Item No. 1: Excavation and Backfill - Binning Construction \$17,497.80
(bid does not include 1. dewatering due to subwater conditions
2. shoring due to subwater conditions or trees)

Sulenta Construction \$26,830.00
(includes above items plus heating concrete to prevent freezing)

Big Item No. 2: Concrete footing, foundation walls, floor, stairs, exterior ramp and sidewalks

Sulenta Construction \$83,477.00

The total of the two bids was considerably higher than anticipated and would exceed more than half the amount budgeted for the addition. Commissioner Tomassi moved that the bids be held in abeyance until the next regular meeting and that architect-project manager John Frullo review the plans to determine if any changes or alterations can be made to lower the cost. Motion seconded by Commissioner Johnston and carried. Further discussion suggested delaying the project until spring to save concrete heating costs and the possibility of using county equipment and manpower to do the excavating work. The decision whether to accept or reject any or all bids will be made at the October 18th meeting.

The commissioners agreed that the county will replace the bridge across the irrigation ditch, between Shelter Park and the Fremont Lake Road when the required right-of-way easements are granted by Bert Reinow, Crowell Dean and owners of adjacent lots in the Orcutt Hill Subdivision.
