The Pinedale town administrator, mayor and two council members attended the meeting at the commissioners request to discuss an agreement for housing the county-owned ambulance in the town-owned fire department building. It was mutually agreed that the ambulance will be housed in the building for a five year period and the town will be reimbursed for the prorated difference resulting from increased utility expense of heating this portion of the building. The town attorney will draw up an agreement between the town and hospital board.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
November 15, 1983

The Sublette County Board of Commissioners met in regular session at 9:00 a.m. with Chairman Floyd E. Bousman, Members Gordon Johnston and Louie Tomassi and County Clerk Lois Yake present.

Minutes of the previous regular meeting were read. There being no additions or corrections the minutes were accepted and filed as read.

The commissioners accepted a proposal for a John Deere crawler as submitted by Greg Hymas of Plateau Supply, Inc. Commissioner Tomassi moved to finance the new equipment over a three-year period with six semi-annual payments of \$23,642.84 each plus 8% interest. Motion was seconded by Commissioner Johnston and passed.

Commissioner Johnston moved to accept the lone bid received of E & L Motors for a 4-wheel drive vehicle for the sheriff's department and to apply the \$1500.00 cash derived from private sale of county-owned 1978 Chevrolet towards the purchase price of \$11,673.28. Commissioner Bousman seconded the motion. Motion passed.

Commissioner Tomassi moved that Tagg Guio be appointed to the Big Piney Airport Board to fill the unexpired term of Kenneth Guio, who resigned, as recommended by the Town of Big Piney. Motion was seconded by Commissioner Johnston and passed.

Laurie Gudim reported on services provided by the Sublette County Sexual Abuse and Family Violence Task Force since she was hired as half-time director. She also expressed concern that population growth, due to
