A RESOLUTION AUTHORIZING AND DIRECTING THE BOARD OF COUNTY COMMISSIONERS OF SUBLETTE COUNTY, WYOMING, TO MAKE APPLICATION TO THE WYOMING FARM LOAN BOARD FOR A MINERAL ROYALTY GRANT OF \$1,000,000.00 FOR IMPROVEMENT WORK NEEDED ON THE CALPET ROAD, PHASED OVER TWO GRANT CYCLES, WITH \$500,000.00 OF SUCH GRANT BEING REIMBURSED BY SUBLETTE COUNTY BEGINNING IN THE FISCAL YEAR OF 1986, FROM ANTICIPATED INCREASES IN AD VELORUM TAXES GENERATED BY THE LABARGE PROJECT.

Architect John Frullo stated that bid specifications for the courthouse addition are now complete and ready to advertise for bid. Projected construction time is mid-January to mid-October, 1984.
