

RESOLUTION NO. 84-63B

A RESOLUTION AUTHORIZING THE LEASE PURCHASE OF A JOHN DEERE CRAWLER TRACTOR, AND ACCESSORIES, AND DIRECTING THE CHAIRMAN TO EXECUTE A LEASE PURCHASE AGREEMENT.

WHEREAS, the Superintendent of the Road and Bridge Department is in need of a crawler tractor, has examined specifications and negotiated with various equipment dealers, and has recommended to the Commissioners that the County acquire a unit from Plateau Supply, Inc.

WHEREAS, the commissioners accept the recommendation of the Superintendent.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLETTE COUNTY, WYOMING:

- 1. That the County enter into a lease-purchase agreement with Plateau Supply, Inc., for the acquisition of a JohnDeere 850 Crawler Tractor, with ATECO HWD 6-in-1 hydraulic wing dozer, and ATECO PS-JD850 ripper with 3 shanks.
- 2. That the Chairman execute a lease-purchase agreement for such acquisition.

RESOLUTION NO. 84-64B

WHEREAS, the Board of County Commisisoners of Sublette County deems the public interest requires a road be established to be known as the LANDER CUTOFF COUNTY ROAD NO. 23-132;

WHEREAS, the foregoing roadway traverses through parts of Sections 21, 17, 18, and 19, T30N, R104W, and Sections 24, 23, 26, and 27, T30N, R105W, Sublette County, Wyoming, which are public lands of the United States of America;

WHEREAS, the Federal Land Policy and Management Act of 21 October 1976 requires the obtaining of a right-of-way across these lands from the Bureau of Land Management;

NOW THEREFORE, BE IT RESOLVED, that the Board of County Commissioners be authorized to apply for a right-of-way across the aforesaid lands in the name of the COUNTY OF SUBLETTE and that the Chairman of the Board, Floyd E. Bousman, or his successor, be authorized to sign the application in the name of the Board and County;
