There being no protests filed Commissioner Johnston moved to adopt Resolution 84-69B authorizing transfer of unanticipated revenue from state and county sources to establish a budget fund for the Civil Defense Co-Ordinator of Area V and the transfer of the unexpended appropriation balance from Courthouse & Jail-Capitol Improvements to Depreciation Reserve. Motion seconded by Commissioner Tomassi and carried.

RESOLUTION NO. 84-69B

A RESOLUTION AUTHORIZING TRANSFER OF UNANTICIPATED REVENUE FROM STATE AND COUNTY SOURCES TO ESTABLISH A BUDGET FUND FOR THE CIVIL DEFENSE CO-ORDINATOR OF AREA V AND THE TRANSFER OF THE UNEXPENDED APPROPRIATION BALANCE FROM ONE DEPARTMENT TO ANOTHER.

WHEREAS, due to requirements that were not reasonably foreseeable at the time the budget was adopted, it is now necessary to transfer the sum of \$20,763 in Unanticipated Revenue and \$200,000 from the Courthouse and Jail budget to supplement the following funds in the amounts shown:

Civil Defense Co-Ordinator Area V	\$ 26,763
Depreciation Reserve	\$200,000

WHEREAS, public notice has been published as required in Section 9-7-319, Ch. 49, Session Laws, 1980, and no protests filed,

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the amount of \$220,763 be transferred to supplement the aforementioned budgets.
